



UGANDA VISA APPLICATION REQUIREMENTS:

All applications must be submitted in duplicate, with the following:

1. 2 passport size photographs
2. Valid Passport – Minimum validity is 6 months
3. **ALL VISA FEES MUST BE PAID INTO THE EMBASSY VISA ACCOUNT BELOW. NO CASH SHALL BE RECEIVED AT THE EMBASSY. ALL PAYMENTS SHOULD BE MADE AT THE TIME OF APPLICATION. THE FEE, ONCE PAID AND RECEIPTED IS NOT REFUNDABLE.**

For Applicants that do not use Net bank to transfer the visa fee: please include a fee for the bank charge, DKK 25.00

For Applicants outside Denmark: the bank charge is DKK 40.00, for each bank transfer.

4. Supporting papers:
- a) Letter by the sponsoring organisation.
 - b) Letter from employer. (if different from 'a')
 - c) Evidence of financial support while staying in Uganda.

PLEASE NOTE:

The Consular Section is open from: 9.30-12.00 noon
It takes 2 days to process the visa.

Additional information or personal interview may be required by the Consular Officer.
Applications should be forwarded to the above address.

10. Return of Passports to Applicants:

ALL APPLICANTS WHO CANNOT COLLECT THEIR PASSPORTS PERSONALLY FROM THE EMBASSY MUST ARRANGE IN ADVANCE FOR **COURIER SERVICES** TO HAVE THEIR PASSPORTS PICKED FROM THE EMBASSY AND DELIVERED TO THEM.

THE EMBASSY SHALL NO LONGER TAKE THE RESPONSIBILITY TO POST OR SEND PASSPORTS BY REGISTERED POST OR COURIER TO INDIVIDUAL APPLICANTS.

ALL VISA APPLICANTS CAN OBTAIN ENTRY VISAS TO UGANDA AT ANY OF THE FOLLOWING: EMBASSY OF THE REPUBLIC OF UGANDA, COPENHAGEN, ENTEBBE INTERNATIONAL AIRPORT, OR ANY ENTRY POINT – I.E.BORDERS.

Note:

Applicants are advised to confirm with the Embassy whether their passports are ready for pick-up, before sending /notifying the relevant courier to collect them.
